22. Handling of Personal Information

The organizer and JAAF recognize the importance of personal information and handle personal information in accordance with laws and regulations related to the protection of personal information and the organizer's personal information protection policy.

23. Doping control

- (1) This competition is subject to doping tests in accordance with WA anti-doping rules and regulations, and/or Japanese anti-doping regulations.

 Doping tests will take place from 11:59 p.m. on the day before the competition until testing is completed, and urine and/or blood samples will be collected.

 If you are subject to doping tests, you must undergo test in accordance with the instructions of the inspector (please note that blood sampling may take place two hours after the end of the competition/exercise).

 In addition, please check the Japan Anti-Doping Agency (JADA) website in advance for details on the above rules and regulations and doping tests.
- (2) If you are subject to doping tests, you will need to present photo ID. Please bring your student ID card, employee ID card, driver's license, or a copy of your passport with a clear photo.
- (3) Participants in this competition (including those who are under the age of 18) are seemed to have agreed to be subject to doping tests in accordance with the Japan Anti-Doping Code at the time of entry.

For participants under the age of 18, entry for this competition shall be seemed to constitute consent by their legal guardians.

Therefore, participants who refuse or evade doping tests (regardless of the type of sample, such as urine or blood), fail to follow the instructions of inspector, or are unable to complete the doping test procedure due to personal circumstances such as travel on the return journey, may be in violation of anti-doping rules. Please note that if you are found to have violated anti-doping rules, you will be subject to sanctions in accordance with the Japan Anti-Doping Code.

(4) Notwithstanding the above (3), participants under the age of 18 must bring a consent form signed by their parent or guardian to the competition.

Participants under the age of 18 must submit a consent form signed by their parent or guardian to the inspector when undergoing doping tests.

Please note that the submission of a consent form from a parent or guardian is required only once for those under the age of 18. If you are subject to doping testing again after submitting the consent form, you must inform the inspector that you have already submitted the form.

If you are unable to submit a consent form from your parent or guardian at the doping control site, please mail it to the JADA within 7 days after the test.

Even if a consent form is not submitted at the time of the doping test, it shall not affect the doping test procedure in any way.
